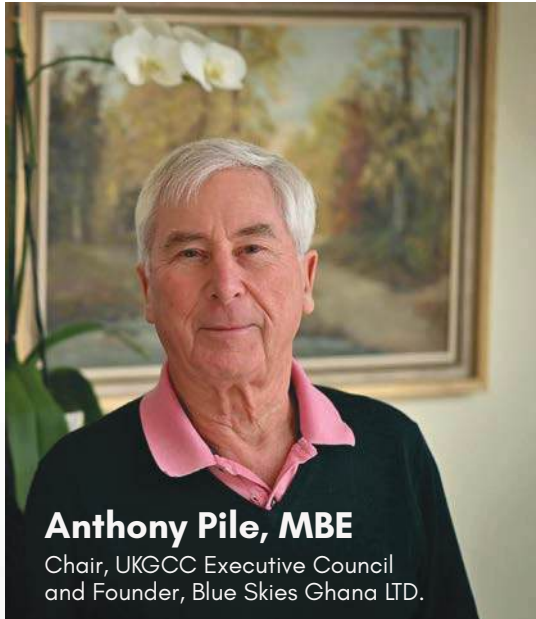

UK-GHANA CHAMBER OF COMMERCE CHAIRMAN'S WELCOME ADDRESS AT THE 3RD END OF YEAR GALA DINNER AND AWARDS ON SATURDAY, 8TH NOVEMBER 2025 AT THE KEMPINSKI HOTEL GOLD COAST CITY ACCRA



Honourable Minister of Trade, Agribusiness and Industry, Your Excellency the British High Commissioner to Ghana, members of the UKGCC's Executive Council and UK-based Advisory Board present, CEOs and representatives of our member companies, key stakeholders and special guests, good evening and a warm welcome to the 3rd UK-Ghana Chamber of Commerce end of year gala dinner and business awards on the theme, "UK-Ghana Trade: Bridging Nations, Building Prosperity".

From just five founding members we have grown into a vibrant and growing network of over one hundred companies spanning multiple economic sectors including — manufacturing, medical & life sciences, finance, energy, agribusiness, telecommunications, technology, consulting, tourism and hospitality and education — the UKGCC today stands as one of the strongest bilateral business platforms in the sub-region.

Our mission has been clear from the onset: to promote trade and investment between the UK and Ghana by supporting members, advocating for a conducive business

environment, and connecting opportunities across both markets.

In our nine years of existence, the UKGCC has carried out this mission, proudly and proven our thought leadership by being the only Ghanaian chamber to publish a business insight report, the Annual Business Environment and Competitiveness Survey, which is now in its seventh year of publication. The findings from this annual report are often referred to and have helped shape a fairer, more enabling environment for businesses to thrive. Our advocacy work continues to extend beyond our membership, benefiting the wider business community in Ghana and amplifying our collective impact.

A clear highlight of this year was the two-day UK-Ghana Trade & Investment Forum, organised in collaboration with the UK Government, the 24-Hour Economy and Accelerated Export Development Programmes Secretariat, and DMA Invest. The event welcomed His Majesty's Trade Commissioner for Africa, John Humphrey, and Ghana's Deputy Minister of Trade, Agribusiness and Industry, Hon. Sampson Ahi. The forum was focused on industrial transformation, strategic partnerships, and financing for priority growth sectors. The Forum embodied everything our theme tonight represents—Bridging Nations, Building Prosperity.

Our outbound trade missions this year have also shown, in real and measurable ways, the impact of UKGCC's work:

Our Garments & Textiles Roadshow, in partnership with Ghana Export Promotion Authority (GEPA), Ghana Free Zones Authority, and the UK government funded Ghana Jobs for Economic Transformation (JET) Programme, brought Ghanaian manufacturers to the UK for a five-day mission. It resulted in active partnerships, opening doors for Ghanaian clothing manufacturers in the UK market.

The Jewellers Trade Mission, designed in partnership with GEPA and the Jewellers Association of Ghana, saw our delegation receive hallmarking and production training in Birmingham, UK. It has already inspired tangible institutional collaboration, with the Ghana Standards Authority planning to upgrade its assay office and procure modern hallmarking machinery to meet global standards.

Ladies and Gentlemen, our networking events remain among some of the most sought-after in the business calendar — something clearly

reflected in the number of non-member sponsors supporting tonight's event. We thank them sincerely for their partnership, and we hope that by the end of this evening, they will decide to make their relationship with us official. (We promise — membership has its privileges!)

Beyond trade, policy advocacy, and networking, UKGCC continues to make a difference in the community.

This year, through our social impact drive, we are raising funds to support the Princess Marie Louise Children's Hospital because for us, prosperity is not just about profit — it is also about people.

ECONOMIC IMPACT AWARD



Overview

The economic impact award celebrates companies that have demonstrated exceptional performance in growth, profitability, and size. This award highlights outstanding economic contributions that have helped shape and advance the Ghanaian business landscape.

Entry requirement

To be eligible for this award, participants must have submitted a nomination form to enter the awards and opted into this award category. Additionally, participants were required to submit their audited financial statements for the 2023 and 2024 financial years.

Methodology

The recipient of the economic impact award was determined using three weighted factors:

1. Size (40%): Measured by the organisation's total revenue for the year.
2. Profitability (30%): Assessed using Return on Equity (ROE), calculated as net profit as a proportion of shareholders' funds.
3. Growth (30%): Assessed by calculating the organisation's compound annual growth rate (CAGR) in revenue over the past two years.

Evaluation process:

1. Audited financial statements for 2023 and 2024 are required. For banks, turnover is defined as interest income plus fees and commission plus other operating income.
2. Financial statements are analysed to determine size, profitability, and growth.
3. Each criterion is scored on a standardized scale. Weighted scores are combined into a composite score.
4. Companies are ranked based on composite scores. Ties are resolved by profitability, then growth.
5. The organisation with the highest composite score is declared the winner.

OUTSTANDING UK BUSINESS IN GHANA AWARD

Overview

The outstanding UK business in Ghana award celebrates UK businesses that have demonstrated exceptional growth and profitability within the Ghanaian business environment. This award recognises the remarkable achievements of UK-originating companies that have excelled in their operations and made significant contributions to the local economy.

Entry requirement

To qualify for this award, participants must have submitted a submission form and opted into the economic impact award category. Eligibility was limited to UK-originating businesses. As this award continues from the previous economic impact award, participants were also required to provide audited financial statements for both the 2023 and 2024 financial years.

Methodology

The recipient of the outstanding UK business in Ghana award was determined using three weighted factors:

1. Size (40%): Measured by the organisation's total revenue for the year.
2. Profitability (30%): Assessed using Return on Equity (ROE), calculated as net profit as a proportion of shareholders' funds.
3. Growth (30%): Assessed by calculating the organisation's compound annual growth rate (CAGR) in revenue over the past two years.

Evaluation process:

1. Audited financial statements for 2023 and 2024 are required. For banks, turnover is defined as interest income plus fees and commission plus other operating income.
2. Financial statements are analysed to determine size, profitability, and growth.
3. Each criterion is scored on a standardized scale. Weighted scores are combined into a composite score.
4. The UK-originating company with the highest composite score is declared the winner.

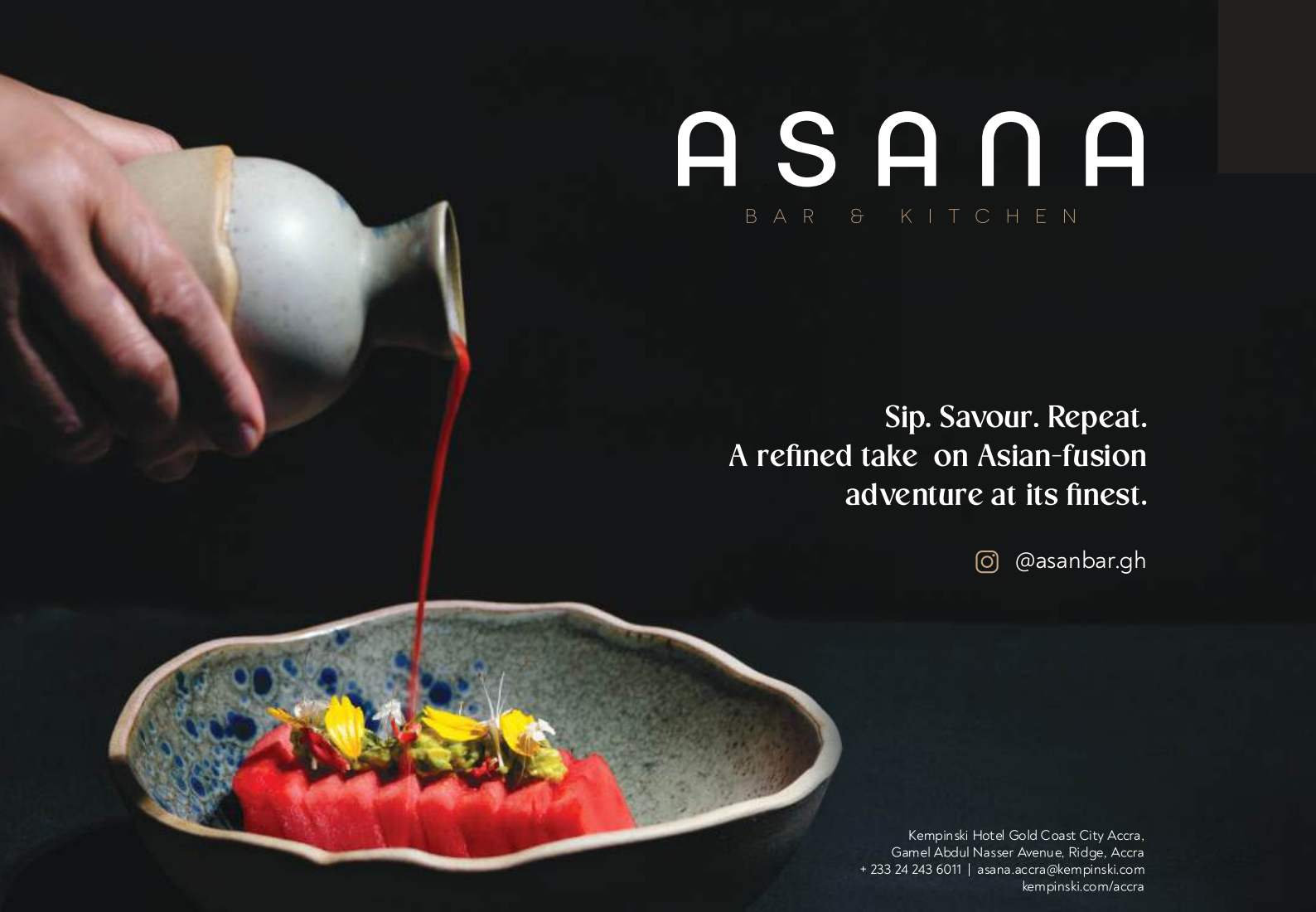

SOCIAL IMPACT AWARD



Overview

The social impact award celebrates companies that have demonstrated a strong commitment to social responsibility, inclusive governance, and community development. This award recognises organisations that have embedded social impact into their core operations, contributing meaningfully to Ghana's social and economic progress.

Entry requirements

To be eligible for this award, participants must have submitted both a submission form and a signed attestation form to enter the awards and selected the social impact award category. They were also required to provide videos showcasing a social project undertaken between 2023 and 2024. While the initial requirement was for nominees to submit a video, a significant number of participants provided alternative file types to document their projects. These variations have been accepted as valid submissions.

Methodology

The recipient of the social impact award was determined using three weighted factors:

1. Impact (40%): Assessment of net employment creation across 2023 and 2024, alongside Diversity & Inclusion ratios, including the proportion of female employees and employees with disabilities.
2. Social governance (30%): Assessment of CSR and Diversity & Inclusion policies and their approval status.
3. CSR project video (30%): Evaluation of project evidence and documentation of direct beneficiaries and testimonials.

Evaluation process:

1. Policy documents, signed attestation, evidence of CSR project, and employee data for 2023 and 2024 are required.
2. Declarations are verified against appended documents. Social governance scores default to zero if evidence is not provided.
3. Employment Creation and CSR scores are scaled using named multipliers to align with Diversity & Inclusion scores.
4. Standardised sub-scores are weighted and combined. Organisations are ranked on composite scores.
5. The organisation with the highest composite score and complete documentation is declared the winner.

PARTNERSHIP AWARD



Overview

The Decades of UK-Ghana business partnership award honours UK-originating businesses that have demonstrated a sustained commitment to operating in Ghana for over fifty years. This award celebrates the enduring impact of these long-standing partnerships on Ghana's economy and society, recognising organisations that have built resilient and meaningful business relationships across generations.

Entry requirement

To qualify for this award, participants must have completed both a submission form and a signed attestation form. Eligibility was limited to businesses based in Ghana with origins in the United Kingdom, and that have demonstrated at least 50 years of continuous operation within Ghana.

Methodology

The recipient of the decades of UK-Ghana business partnership award was determined using two weighted factors:

1. Impact on local employment creation (60%): Net employment created over 2023-2024, using a non-negative measure.
2. Tenure in Ghana (40%): Verified years of continuous operation, with a minimum threshold of 50 years.

Evaluation process:

1. UK origin and at least 50 years of continuous operation were verified for all nominees.
2. Employee data was reconciled for each organisation. Negative values were removed from net employment creation.
3. Employment creation and tenure scores were computed on standardised scales and weighted.
4. The eligible company with the highest composite score was declared the winner.

BEST TAX PAYER AWARD



Overview

The best tax payer award recognises organisations that demonstrate a strong compliance culture and transparency in Ghana. The award highlights timely and accurate fulfilment of statutory obligations and disclosures.

Entry requirement

To be eligible for this award, participants must have completed a submission form to enter the awards and selected the tax compliance award category, indicating their interest in being evaluated by the Ghana Revenue Authority (GRA). Only businesses assigned to the Large Taxpayer Office are eligible for tax compliance metrics provided by GRA.

Methodology

The recipient of the best tax payer award was determined based on the total tax paid, which includes all applicable tax types for each business. Tax types considered are corporate income tax, e-levy, financial sector recovery levy, growth and sustainability levy, national fiscal stabilization levy, NHIL/GETFund/COVID-19 levy, pay as you earn (PAYE), VAT/CST on imported services, withholding tax, withholding VAT, VAT flat rate (real estate), value added tax (standard), personal income tax, stamp duty, communication service tax, and NHIL/GETFund.

Evaluation process:

1. Names of nominees that opted into this award category were submitted to the Ghana Revenue Authority (GRA) for evaluation.
2. Nominees assigned to the Large Taxpayer Office (LTO) were shortlisted.
3. GRA assessed and reported that all LTO-assigned businesses filed their returns and made payments on time.
4. The distinguishing factor was the total tax paid by each business, as detailed in the records provided by GRA.
5. The organisation assigned to the LTO with the highest total tax paid amount was declared the winner.

DYNAMIC MEMBER AWARD



Overview

The most dynamic member award recognises the UKGCC member company who has demonstrated consistent and multifaceted engagement with the UKGCC across the areas of Member in good standing, Sponsorship of UKGCC events, business advocacy, and trade services. The assessment period spans 2023 to date, and the shortlisted nominees have each made meaningful contributions to the UKGCC's mission of promoting trade between the UK and Ghana.

Entry requirement

There were no formal entry requirements for this award. All UKGCC members in good standing were automatically qualified for evaluation. Eligibility was determined based on active and consistent membership, demonstrated through renewal and participation in UKGCC activities.

Methodology

The recipient of the most dynamic member award was determined by evaluating four areas:

1. Membership in good standing, maintained through annual renewal and participation in UKGCC activities.
2. Sponsorship of UKGCC events and initiatives.
3. Participation in UKGCC's business advocacy efforts to support a more enabling business environment in Ghana.
4. Utilisation of UKGCC trade services, including participation in trade missions, capacity building forums, and business thought leadership programmes.

Evaluation process:

1. Records of membership renewal and participation were reviewed for the assessment period.
2. Sponsorship activities and support for UKGCC events were documented.
3. Advocacy involvement was assessed based on contributions to UKGCC's policy and business environment initiatives.
4. Engagement with UKGCC trade services was evaluated through participation in relevant programmes and missions.

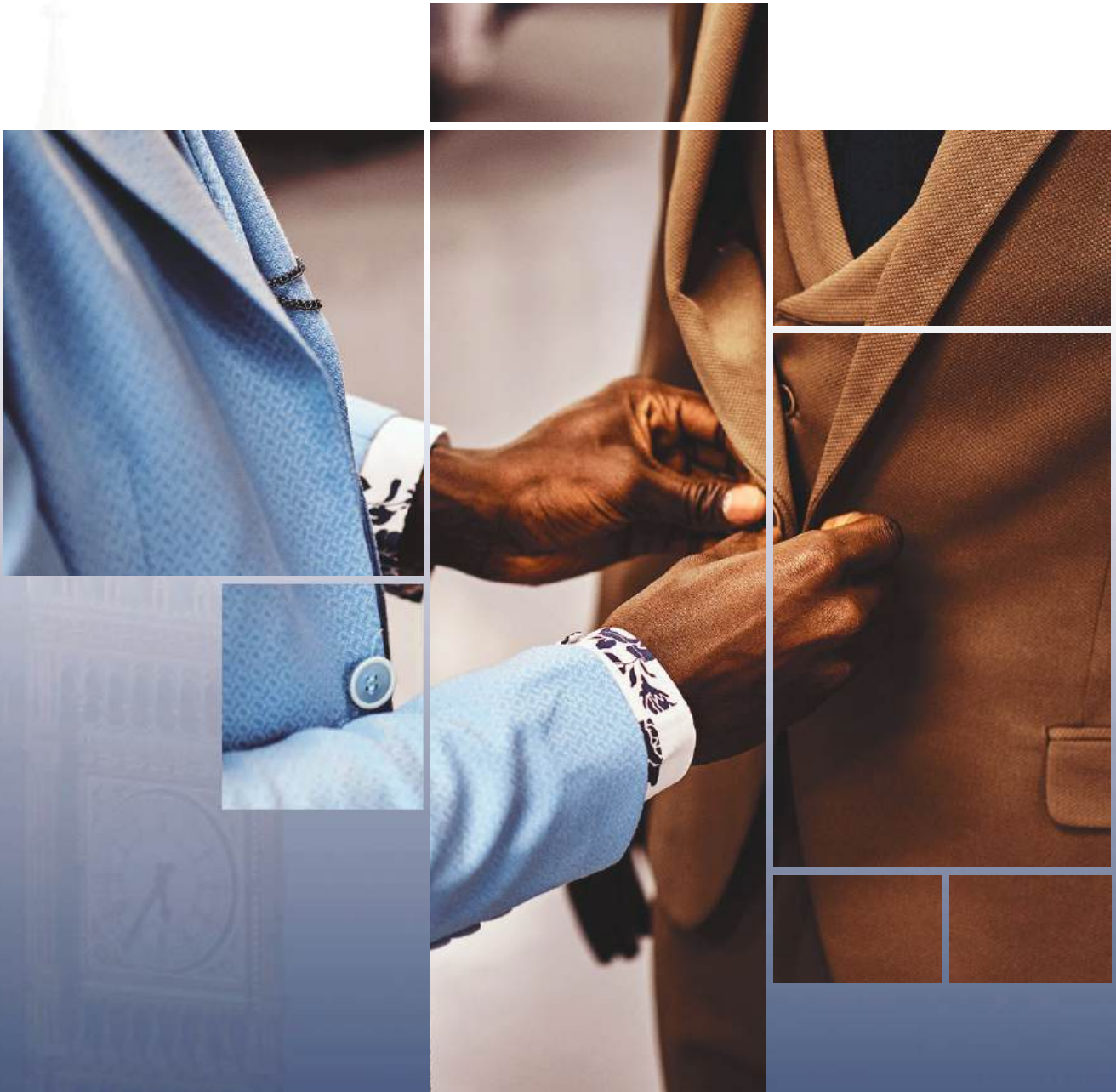
