# Covid-19 Quarantine rules in the UK

---

On arrival in London, you will be required to quarantine. You can take a test no earlier than the 5th day after arrival.

If the result of your day 5 test is negative (and the result of your day 2 test result was negative or inconclusive) you can stop quarantine as soon as you receive the result.

You still need to take the compulsory test on or after day 8.
